Consent Form:

We consent to my/our daughter/son participating in the Dalton Holidays Festival Little Miss Snowflake/Little Jack Frost Contest.

We understand the obligations and regulations of this title and agree to follow them.

We will also sign a medical release form and give it to the Queen's chaperone.

I/We acknowledge we must attend a mandatory meeting the 1st Sunday in November at 2pm at the Dalton Presbyterian Church. This must be attended by a parent and the contestant in order to participate in the pageant. All judging will be the 2nd Sunday in November at 2pm.

General Royalty Rules for Each Age/Title:

- 1.Both a parent and the contestant must attend a mandatory pre-contest meeting to compete.
- 2. Parents of all contestants must sign a photography release form.
- 3.New Queen and Court parents will meet with festival members after Jan. 1st to go over what festivals the Queen and Court usually attend. This will be a preliminary schedule for the families to work with when making necessary plans for traveling. The luncheon invitations do not always include the court due to individual festival restrictions, however, the court members may participate in the parade. The queen will work with the chaperone to select festivals and will assist with inviting the court as appropriate.
- 4. You are required to have a picture taken for festival use with your crown, sash, flowers, and trophy for promotional material by the end of February. The festival will make arrangements; you will just have to be at the appointment dressed appropriately. The pictures are optional for you to purchase.
- 5. You must wear festival attire, such as crown, hat, sash, charm bracelet, etc. at all times while at events.
- 6.Please realize some planning for travel is done at the last minute, however, we do the best we can communicating to all parents.
- 7. You need to contact the Royalty Coordinator if you have changes in address or telephone number during your reign.
- 8. While representing the Dalton Holidays Festival, we ask you be on your best behavior. Remember, your reign begins as soon as you are crowned to the close of the next festival.
- 9. The use of profanity, inappropriate slang terms, and ethnic/racial jokes or slurs is prohibited. As is the use of illegal drugs, alcohol, and tobacco products.
- 10. The Royalty Coordinator and festival committee have the option to relinquish a title in the event of disobeying rules or misbehavior at a festival level or as high as our legal system. This also applies while attending school. Being expelled from school will also result in the relinquishment of title.
